

INSTALACIÓN DEL DISCO DURO

Disk Station requiere como mínimo un disco duro SATA de 3,5" para la instalación. Consulte los siguientes pasos para obtener más información:

Advertencia: Si utiliza un disco duro con datos para realizar la instalación, el sistema lo formateará y borrará todos sus datos en algunos casos. Realice una copia de seguridad de los datos si los va a necesitar en el futuro.

1. Empuje el clip en la dirección mostrada a continuación.



2. Retire la bandeja de la máquina.



3. Fije el disco duro SATA a la bandeja del disco duro mediante 4 tornillos.



4. La posición del disco está numerada como se indica a continuación. Comenzando desde la izquierda: HDD1, HDD2, HDD3, HDD4 y HDD5, respectivamente.



5. Inserte la bandeja del disco duro.



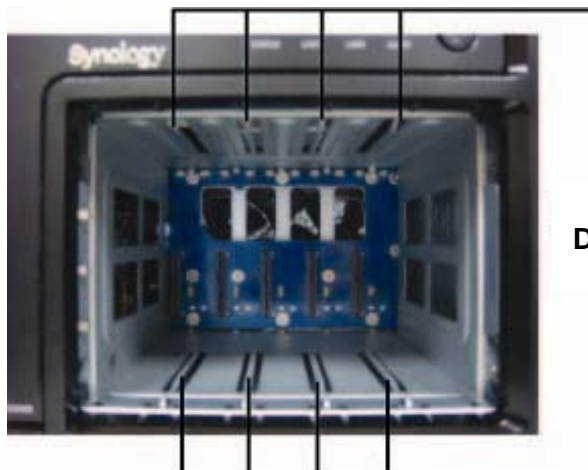
Aviso: Compruebe que la bandeja esté bien fijada al sistema. En caso contrario, es posible que el disco duro no funcione correctamente.

- Repita el paso anterior para ensamblar todos los discos duros que haya preparado.

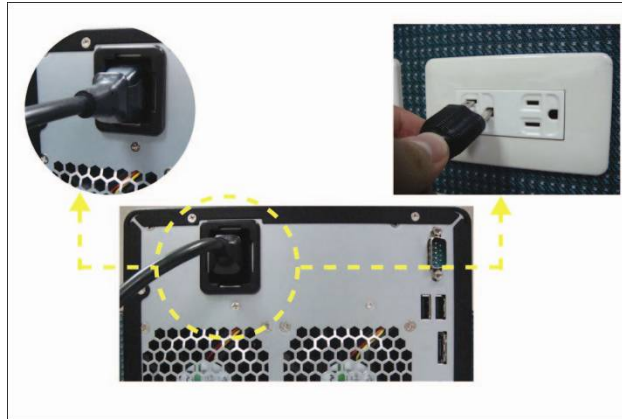
Aviso: Al instalar las bandejas de los discos duros, compruebe que las bandejas se insertan correctamente por los raíles superior e inferior respectivos.

3. Pulse el botón de encendido del panel frontal para encender el servidor. Espere a que el LED de encendido (POWER) esté azul de manera continuada.



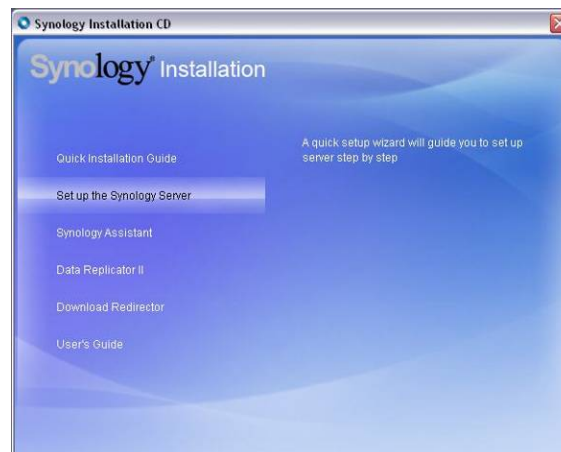

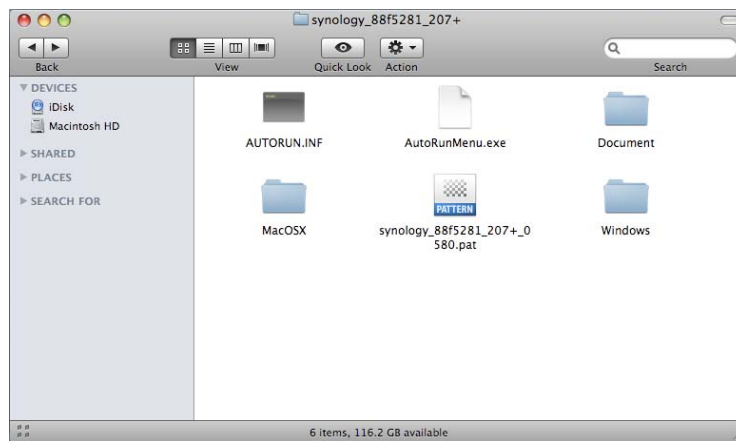
1. Inserte el CD de instalación en el equipo.



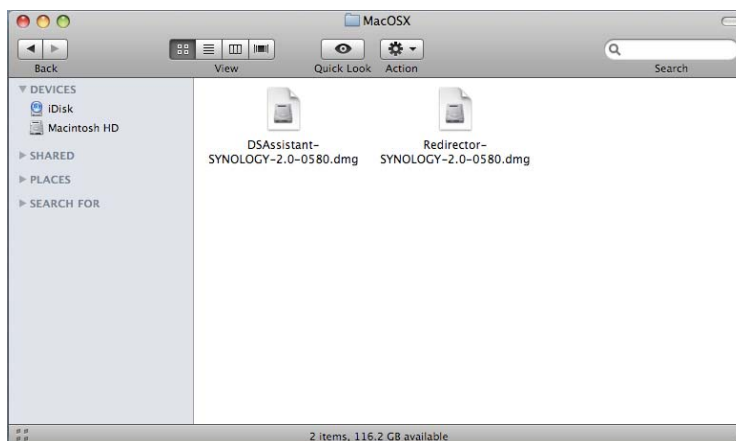
2. Haga doble clic en la miniatura de la unidad de CD-Rom.



3. Haga doble clic en la miniatura "MacOSX".



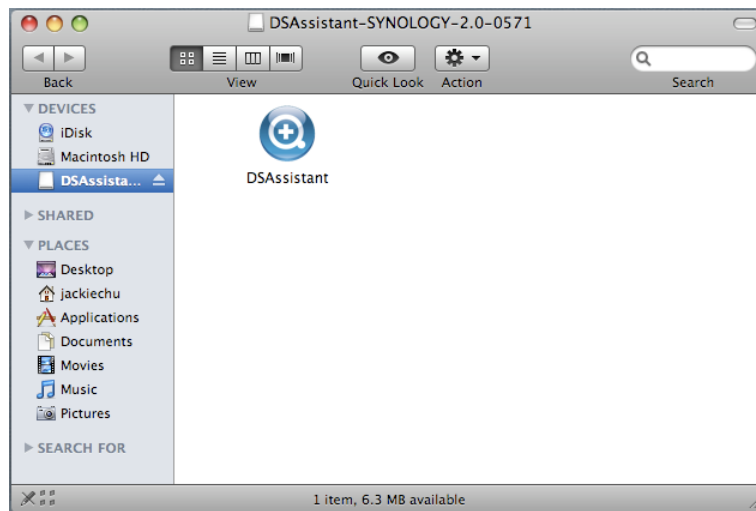
4. Haga doble clic en la miniatura "Synology Assistant-SYNOLOGY.dmg".

Preamble
